Regarding: 2025-2026 Basketball Entry Information

The La Porte Park and Recreation Department's Adult Basketball Program will return on Sunday, November 9, 2025. We will host two days this playing season.

Sundays: Competitive Play
Tuesdays: Competitive Play (limited to 8 teams)

Enclosed is the team entry information for the 2025-2026 basketball program.

1) Team Entry Information

- a) **Team entry deadline Friday, October 24, 2025**
- b) Team Entry Fee - **\$250 per team** (all leagues) if paid on or before October 24, 2025, deadline; after deadline, \$275 per team provided space exists.
- c) Officials' Fees - \$455 (+) **CASH** throughout the season to be paid each game prior to tipoff- including playoffs. (\$35 per game)
 - \$455 includes the pay of officials for 12 regular season games with 1 playoff game. If your team continues to advance in the tournament, you continue to pay officials \$35 prior to tipoff.
 - If your team does not pay an official \$35 in cash prior to tipoff, money will be taken from your deposit- must be replenished prior to next game.
- d) Forfeit Deposit- \$140. The deposit of \$140 covers 2 forfeits during the season (\$70 per forfeit).
 - Deposit will be returned at the end of the season if not used. If the deposit is used during the season, it must be replenished before your next scheduled game.
- e) **Total fees due** = Team entry fee (\$250) + forfeit deposit (\$140) = **\$390** (If paid on or before the deadline.)
 - Deposit will be returned at the end of the season if not used. If the deposit is drained during the season, it must be replenished before your next scheduled game.
 - **We are only able to accept the \$390 at entry.** The official's fees are to be paid by you each week (\$35 per game).
- f) Team entry fee of \$390 must be paid during office hours before the deadline date to participate in the league. Team applications for the basketball program are not complete unless all fees and necessary information accompany the application. Please do not attempt to turn in partial payment of fees or incomplete forms, as this does not constitute a complete application for entry into the program. Teams will be eliminated because of failure to turn in all entry fees and rosters. Teams entering after the deadline date will be put on a waiting list and entered if space is available (charged the \$25 late fee) and may be placed in a league that needs to be filled.

Please note that even returning teams must submit their roster and fees by the deadline to be considered for league placement. *If you are not planning on being involved in the basketball program as a manager, please pass this information on to the appropriate person.*

Team captain or representative from your team must attend. Missing this meeting will result in forfeit of your first game.**
